BIG 101'S BEAT THE HEAT CONTEST CONTEST RULES

THE BIG 101'S BEAT THE HEAT CONTEST CONTEST (THE "CONTEST") WILL BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

1. ELIGIBILITY.

- 1.1 To be eligible for this Contest, an individual must:
 - (a) be a legal resident of the province of Ontario;
 - (b) be of the age of majority in the province of Ontario;
 - (c) be the sole owner of all right, title and interest (including copyright) in and to the Work (as defined below) submitted in connection with the Contest; and
 - (d) Be the legal owner of a home that is located no further than twenty-five (25) kilometers of 164 Innisfil Street, Barrie ON (not including any locations east of Lake Simcoe. Client does not serve the Georgina/Keswick area), that has an existing central furnace system.
- 1.2 The following people are not eligible to enter the Contest:
 - (a) Employees of, Corus Radio Inc., operating as CIQB-FM (the "Station") and its parent, affiliates, subsidiaries, related companies, successors and assigns (together with the Station, "Corus");
 - (b) Employees of Air Source Home Comfort Inc., its affiliates, subsidiaries, related companies, successors and assigns (collectively, "Air Source Home Comfort", together with Corus, the "Sponsors");
 - (c) Any person who has been confirmed as a winner of two (2) Corus administered contests within six (6) months preceding the Contest start date indicated below where the prize was valued over one thousand Canadian dollars (CDN\$1,000); and
 - (d) The household members of any of the parties listed in Section (a) to (c) above.
- 1.3 The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply information that does not meet these requirements.

2. CONTEST PERIOD. The Contest begins at 12:00 am Eastern Time ("ET") on June 29, 2024 and ends at 11:59 pm ET on July 28, 2024 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

3. HOW TO ENTER.

- 3.1 There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
 - (a) To enter online, complete and submit the entry form located at www.big101.ca/contests (the "Contest Microsite").
- 3.2 Each entrant must submit an entry form together with the a photo (file type must be .jpeg or .png) of their current central air conditioner unit, and brief summary of why they need a new air conditioner unit (the "Work").
- 3.3 By participating in this Contest, each entrant represents and warrants that the Work: (i) does not contain any material, language or gestures that are libelous, defamatory, indecent, profane, obscene or violent and does not violate any laws including without limitation, relating to hate speech or otherwise; (ii) is original, solely created by the entrant and that no third party participated as an author, co-author or otherwise in the creation of the Work or any part thereof; (iii) all right, title and interest (including copyright) therein is owned and/or controlled by the entrant to the full extent necessary to enable the Sponsors to use the Work as contemplated by these Contest Rules; (iv) the Work does not infringe upon the intellectual property rights, rights of publicity, privacy rights, proprietary interests or other statutory or common law rights of any third party; (v) does not contain any recognizable logos or any other copyrighted material; (vi) does not contain any mention, endorsement, or "plug" any commercial product, service, venture or thing, including, without limitation, the name of entrant's employer; and (vii) has not been submitted in connection with any other contest and/or promotional campaign.
- 3.4 Limit of one (1) entry per e-mail address, per household during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.
- 3.5 All entries including the Work, become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- 3.6 Entries received online shall be deemed to be submitted by the authorized account holder of the email address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any entrant may be required to provide the Sponsors with proof that they are the authorized account holder of the e-mail address associated with their entry.

4. PRIZE.

4.1 There is one (1) prize (the "Prize") available to be won by the Prize winner (the "Winner")

consisting of:

- (a) One central air conditioner unit with installation; and
- (b) The removal and disposal of previous air conditioner unit.
- 4.2 The Grand Prize has an approximate value of five thousand five hundred Canadian dollars (CDN\$5,500).
- 4.3 Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- 4.4 The Sponsors and/or the Sponsors' representatives will contact the Winner to coordinate the provision of the Prize within two (2) days once such Winner has been successfully contacted and notified of their Prize and fulfilled the requirements set out herein.

5. PRIZE CONDITIONS.

- 5.1 Prize must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of the Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. The Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if a Prize (or any portion thereof) cannot be awarded for any reason.
- 5.2 Prize must be installed and all work completed no later than September 30, 2024.
- 5.3 Must be a replacement central air unit. Prize does not include ductless, window and/or floor air conditioner units. The Prize does not include replacing any duct work or additional work above and beyond the installation of the Prize and disposal of the old unit. The Prize must have the ability to connect into existing central furnace.
- 5.4 Shipped Prizes shall not be insured and the Sponsors shall not assume any liability for lost, damaged or misdirected Prizes.

6. WINNER SELECTION.

- 6.1 One (1) Winner shall be selected as follows:
 - (a) On or about July 29, 2024 in Barrie, Ontario, one (1) entrant will be selected by a random draw from all eligible entries received during the Contest Period. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail to comply with the Contest Rules and to sign and return the Release (described below).
 - (b) THE SELECTED ENTRANT WILL BE NOTIFIED BY TELEPHONE NO LATER THAN JULY 29, 2024 AT 8:30A.M. ET AND MUST RESPOND WITHIN TWO (2)

BUSINESS DAYS OF NOTIFICATION. Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, they will be disqualified and will not receive the Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.

- (c) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.
